Boxers competing at Box Cups in Scotland

This document is to be fully completed by all clubs entering Box Cups taking place in Scotland during the season. We would like to inform travelling teams of the process for obtaining permission for boxers to compete in Box Cups within Scotland from other Home Nations or International Federations.

This document is to ensure insurance is in place for all travelling clubs and competing Boxers and must be completed in full. PLEASE NOTE Boxing Cups are for Clubs only – no National Teams will be given permission to box.

Box Cup organisers must contact all clubs and entries entering events in Scotland to ensure the correct permission for visiting boxers to attend such events, clearly identifying the following information in writing:

- 1. Approval to participate has been given by Home Nation. (Relevant approval emails, letters)
- 2. Name of visiting Club.
- 3. Proof of A National Governing Body affiliation.
- 4. Proof of Affiliation for Current Season.
- 5. Club Affiliation Number; (If applicable)
- 6. Name of Club representative responsible for Child Protection during the event.
- 7. Lead Coach Details.
- 8. Names of all coaches travelling.
- 9. Names of all boxers and records (Bouts, W, L)

The visiting Club must provide confirmation that permission has been granted from their governing body, the names of the boxers and clubs this must be shown to the Supervisor of the event, prior to boxing commencing.

A Club Coach lead must ensure they have a up to date list of the travelling party and hold NOK details for all during the event.

This approval letter or email must be presented to the event organisers prior to the event with a copy supplied to event supervisor otherwise boxers will be prevented from competing.

The Box Cup organising committee must forward a copy of all documents from all clubs taking part in the event to Boxing Scotland office no later than fourteen working days prior to the event.
